There is no floor or ceiling regarding grant size. The Distribution Committee of the Trustees may decide to partially fund a request.

*These descriptions must not exceed two pages in length combined.*

- 6) A copy of your organization's budget or cost estimates for the program for which you are requesting the grant. This budget or estimate must explain how the grant amount you are requesting will be used for an existing program or a proposed program.
